Agenda: (Twiss/Jones) Motion to approve the agenda with changes. Unanimously approved.

(**Twiss/L.Strong**) Motion to approve the minutes of June 3, 2008 as presented. Unanimously approved.

(**T.Strong/Dell**) Motion to approve the Special Meeting minutes of June 9, 2008 as amended. Unanimously approved.

(**Jones/Twiss**) Motion to approve the June 2008 Bill Package totaling \$29,767.52 including the removal of the 1st Qtr 2008-09 Township Fire Protection Fee invoice. Roll call vote: Unanimously approved.

(**T.Strong/Dell**) Motion to approve the May 2008 Treasurer's Report as presented: Major Streets = \$127,629.67; Local Streets = \$46,467.23; General Fund = \$89,934.46; Water Fund = \$60,923.91, Perpetual Care Fund = \$11,406.63; Totals = \$336,361.90. Roll Call Vote: Unanimously approved.

- 1) Infrared repair Pavement Restoration, Inc.

 - East Maple (Ebinger to Maple Circle) @ \$630.00 (Major Streets)
- 2) Micro Seal repairs

(**T.Strong/Jones**) Motion to approve Pavement Restoration, Inc. to perform the above listed repairs for a total of \$32,949.00 (Major Streets \$32,655, Local Streets \$294). Roll call vote: Unanimously approved.

Parks: Mr. Dell will inquire whether the owner of the property behind the cemetery would sell the property to the village for expansion of the cemetery.

Administration: Mr. Jones will pull together a job description and application in the next two weeks.

Public Safety/Fire:

The Regular meeting was called back to order to discuss the township millage proposal. (**T.Strong/Dell**) Motion to write a letter of recommendation to the Township Board for a 1 mill, 3-year millage proposal. Unanimously approved.

Discussion centered on the 2 mill proposal and perhaps the amount is too high and that a lower millage proposal would be sufficient. Reviewing township tax figures, a 1 mill proposal should provide adequate funding for the fire department, still benefit the township general fund, equal funding for all township residents and provide a test or trial run for this new approach at funding the fire department.
